Annual Meeting of Members Held at Naples Yacht Club

The Annual Meeting of The Yale Club was held on Thursday, November 13th at the Naples Yacht Club. Thirty members were in attendance to hear reports of last year's activities and learn about plans for this season. President Torrey Foster '56 presided over the meeting. After a call to order, there was some discussion about the reading of the minutes of last year's meeting. It was finally agreed to accept the minutes as presented.

Committee reports were received from Activities (Bob Bennett '44), Alumni Schools (Tom Mackelfresh '51), AYA (Terry Upson '60), and Endowment (Bob Wenzel '53), all of which are reported elsewhere in this issue. Ted Gault '54 MDiv reported on the forthcoming activities in our Ft. Myers branch which continues to be active for Lee County members.

Foster gave a financial report of the Club's operations for the nine months ending September 30th, the end of the new fiscal year for the Club. The Club has \$4,780 balance in its operating account and an Endowment Fund balance of \$71,030.

Tom Wheeler '58 made some very complimentary remarks about Torrey Foster's two years as President and presented him with a pewter bowl as a token of the Club's appreciation for his service in leading the Club.

Thomas Wheeler '58

With a grandfather in the class of 1895, a father in the class of 1923, and a brother in 1954, attending Yale seemed like a very natural decision for Tom. Graduating in 1958, he was a member of the Glee Club, business manager of the Bachelors (a singing group since disbanded) and a Beta Theta Pi. He has been a trustee of the Yale Club for two years and succeeded Torrey Foster as President in November.

After concluding two years of active duty in the Navy as Lieutenant (jg) following graduation, Tom joined IBM as a computer sales trainee and two years later moved to Mass Mutual Life Insurance Company as a sales agent in Boston. He was appointed General Agent in 1976 and moved to the corporate headquarters in Springfield, MA in 1983. Tom retired in 1999 after having been CEO of the company for 10 years, 5 years as president and 5 years as chairman.

He is currently a member of the Board of Directors of the Conservancy of Southwest Florida, Woods Hole Oceanographic Institution in Woods Hole, MA, the Basketball Hall of Fame in Springfield, MA, Textron Inc. in Providence, RI, and Estateworks in Maynard, MA. He is a past director of BankBoston and former Massachusetts States Chairman of the US Olympic Committee.

Tom enjoys tennis and boating and is a member of the Port Royal Club, Naples Yacht Club, Yale Club of New York, and The Links in New York City.

He and his spouse, Robin (Smith College 1961), have two daughters and 4 1/2 grandchildren. They spend summers in West Falmouth, MA on Cape Cod.

Report on AYA Assembly LXIII

Assembly LXIII, "Yale's Museums, Libraries, and Collections: Treasures for Teaching and Research," began at 10:00 A.M., Thursday, November 20th, with a short introduction by assembly chair Ellen G. McGinnis '82 after which delegates divided into assigned groups (Arts, Library and Natural History) to examine various collections at the Yale Library and museums. My group spent the morning at the Peabody Museum where we reviewed rock, fossil and gem collections as well as the University's Anthropology Collection – one of the largest and most diverse in the United States. The afternoon was spent at the Yale Library viewing one of the foremost academic map collections in the nation followed by a tour of the Beinecke Library's Western Americana Collection and a short talk by George Miles, Curator.

At 3:30 P.M., Barbara Shailor, Deputy Provost for the Arts, led a panel discussion which explored the many ways in which Yale's unique and outstanding collections of art, objects, and texts are wed. Panelists included Michael Donoghue, Director of the Peabody Museum; Susan Matheson, Chief Curator, Yale University Art Gallery, Frank Turner '71 Ph.D., Director of the Beinecke Rare Book and Manuscript Library and John Hay Whitney Professor of History. The evening began with a reception at the Beinecke Rare Book and Manuscript Library followed by dinner at the University Commons. Capping the day's focus on collections, distinguished art historian Amy Meyers, '85 Ph.D., Director of the Yale Center for British Arts, delivered the keynote address reflecting on the role of collections in the educational mission of the university and the ways in which they attract students, scholars, and collectors to Yale.

Friday, November 21st consisted of a leadership conference for alumni volunteers. The day began with a lecture by Dr. Bill Wittich on how to recruit, manage, reward, and recognize fellow volunteers. A former member of the Yale Faculty, Dr. Wittich has authored five books on volunteer leadership including "The Care and Feeding of Volunteers" and "Keep Those Volunteers Around." The remainder of the session consisted of case study breakouts conducted by Yale Alumni who have created innovative programs to engage alumni with each other, with students, and with Yale. I attended a breakout on Turnarounds and New Ventures which focused on starting or re-energizing an alumni group. Individual volunteer leaders talked about their success with the reformulation of the Yale Nursing School Alumni Board, the re-invention of the Spizzwinks Alumni Association, the revitalization of the Yale Westchester Alumni Association and the record breaking turn out achieved by the Yale College Class of 1988 at it's 15th Reunion. I also attended a session on Engaging Students and Alumni which focused on some very successful mentoring programs conducted by the Class of 1959 and Calhoun College, the Yale Law School, and the AYA's very successful Community Service Summer

At 11:00 A.M., the AYA's Executive Director, Jeff Brenzel '75, and the Board of Governors held a town meeting in the newly

renovated Sprague Hall. At this meeting, AYA officers presented the major change to the Assembly Program whereby one major session each year will be held at Yale rather than two. The session will be held on either the Harvard or Princeton weekend each fall, depending on which is the home football game. This change is being made in an attempt to attract and accommodate delegates who are working by shortening time requirements and encouraging more participants. To date this seems to be working as attendance at this session exceeded 500.

The afternoon session concluded with addresses by President Richard C. Levin '74 Ph.D., Vice President and Secretary Linda K. Lorimer '77 JD, and Provost Susan Hockfield on some of the most pressing issues facing both Yale Dr. Levin reported that and higher education today. endowment/giving is down 40% over the past several years, although it picked up during the first half of 2003. In response to this development, the University is attempting to cut administrative expenses by \$30 million per year. He further reported that applications for admission are up considerably, thus far this fall. Provost Hockfield informed the group that the University will continue its building program even while cutting administrative costs and recently broke ground for a new Chemistry Building on Science Hill. Secretary Lorimer spoke on Yale's international effort "The Globalization of Yale" Yale currently teaches 600 which is now in full swing. international courses and 52 foreign languages with 1118 faculty research projects now underway in 99 countries around the world. One student in thirteen now comes from abroad. At present, Yale has 1660 international scholars from 95 countries.

Friday evening featured the Blue Leadership Reception, Dinner and Ball at Payne Whitney Gymnasium with over 800 in attendance. The event featured the presentation of the 2003 George H. W. Bush Lifetime of Leadership Awards. These awards recognize alumni who competed as varsity athletes at Yale and who went on to careers of extraordinary accomplishment and service to others. This year's honorees were: Lisa Brummel '81, William Donaldson '57, John Downey '51, James Duderstadt '64, and Richard Gelb '45. Of particular note was the Honorable John Downey who as a member of the CIA was captured by the Chinese in the early 1950's and was imprisoned in China for over 20 years. Released when President Nixon visited China in the 1970's, he went to law school and is now a Judge in the Connecticut Superior Court.

The Assembly was formally closed Friday evening, although there were various class and school meetings on Saturday morning, November 22nd. Assembly participants then attended the Yale-Harvard Football game and a traditional tailgate party at Cox Cage prior to the game.





Yale Club Endowment Grows for Benefit of Student Scholarships

As of September 30, 2003, the end of the Club's fiscal year, the Endowment Fund assets which are invested with Northern Trust in five separate funds totaled over \$ 71,000. The main purpose of the fund is to provide financial aid to Yale University students from this area. For the past several years the Club has made annual gifts of \$3,000 to the university for scholarship purposes.

Our *In Memorian* Fund which is a part of the whole Endowment Fund and includes memorial contributions for all deceased members of the Yale Club since the beginning of the Club in 1966 totals \$ 10,800. We continue to send letters of condolence to spouses or family.
