## Richard Thornburgh Speaks at Monthly Luncheon

Former Attorney General of the U.S. talks of his legal and government experiences





Richard Thornburgh '54 was the guest speaker at the Yale Club monthly luncheon on January 17th held at the Vineyards Country Club. His legal career encompassed serving as the U.S. Attorney in Pittsburgh, Assistant Attorney General, and as the United States Attorney General. In addition he served as Governor of Pennsylvania, Under Secretary General for Administration in the United Nations, Director of the Institute of Politics at Harvard's John F. Kennedy School of Government, and as a leader together with his wife for the Americans with Disability Act.

Thornburgh opened his comments about his experiences in the international business world. He prosecuted companies, including Lockheed Corporation, under the Foreign Corrupt Practices Act. He was involved in looking at the operations of the World Bank and establishing anticorruption efforts and programs with many organizations.

He was appointed Examiner by the bankruptcy court to investigate the irregular accounting practices of World Com which entered bankruptcy in 2003.

## Lecture Series Kicked Off with Talk by Yale Art Gallery Director Jock Reynolds

Jock Reynolds highlights history of 3rd oldest university museum

Leading off the Yale Club's lecture series this season was a presentation by Jock Reynolds, *The Henry J. Heinz II Director* of the Yale University Art Gallery. Over 90 members and guests attended the event which was graciously sponsored by Northern Trust Co. at its Park Shore Larson community room.

Reynolds pointed out that the gallery is a teaching museum and is organized with eight collecting departments. Although the gallery was initially founded in 1832 with a gift from Colonel John Trumbull, it has been added on to, redesigned, and grown to include more than 185,000 works of art.. It contains stunning examples of early American portraitures of well known revolutionary leaders, including George Washington, and a number of paintings depicting the signing of the Declaration of Independence by John Trumbull, and various battle scenes of the revolution.

The Peale portraits of early Americans are significant because they are the only real representations of the people of the times. And the gallery has a great collection of miniature portraits.

The Yale gallery is the third oldest university art museum in the world after Harvard and Oxford. In 1864 it initiated the first art school in the country, and it was the first school to grant women degrees in Master of Fine Arts.

In 1868 the museum acquired its first paintings of renaissance art. In1928 the museum entered into a major expansion, and started to develop one of the four greatest collections of American decorative art. The museum sees one of its most important missions is to be a leader in public education.

Reynolds concluded his remarks by pointing out that the university is spending over the \$500 million in renovations which are underway. And he showed many slides of significant and important pictures and paintings in the university collection.

Thornburgh pointed out how there was a breakdown in corporate governance, internal audit procedures and almost bribery by outside auditors. The Sarbannes-Oxley Act was enacted as a result of lack of corporate attention to ethics and accurate reporting.

The CBS debacle in reporting on President Bush's National Guard service again brought Thornburgh to the investigative forefront. He headed the committee to investigate the network's failure to meet basic standard of fairness and accuracy.

In 1989 Thornburgh was part of a delegation focusing on the rule of law and educating Russian leaders on how to implement western concepts on the legal system. He noted also that organized crime is now a big problem in Russia.



#### **Trustee Profile**



Samuel P. Cooley '53

Sam was born July 7, 1931 in Hartford, Connecticut and has lived in the Hartford area most of his life. He entered Yale in the fall of 1949 following his graduation from St. Paul's School, Concord, New Hampshire. Not wishing to abandon the student life, he next attended the Columbia Graduate School of Business, receiving an MBA degree in 1955.

Sam married Trig Norstrand (Smith 1952) during his senior year at Yale and was fortunate to have her to support him during three years of education.

Following graduation from Columbia, he returned to Hartford where he joined Hartford National Bank and Trust Company. The bank expanded, acquired other banks, and changed its name twice by the time Sam retired at the end of 1993 as the senior credit officer of Shawmut National Corporation. Shawmut was subsequently acquired by Fleet Financial which was in turn purchased by Bank of America, the current source of his pension checks.

Sam served on the boards of several business entities, the last two of which he retired from in 2004. Though he misses the active involvement, in the current environment he does not miss being the audit committee chairman of two public, SEC reporting companies.

Sam's community activities over the years included serving as a church vestry member, hospital trustee, foundation trustee and treasurer, cemetery trustee and treasurer, member of the Greater Hartford Arts Council board, and the boards of two clubs one of which he served twice as president. He has been an Alumni Fund agent for Yale since 1964, and has been active in fund raising for his class at St. Paul's School for which he currently serves as "Form Director".

Yale has been a long tradition for the Cooley family starting with Sam's grandfather, class of 1891.

## Record Number of Applicants to Yale from Southwest Florida

This year has set a record for applicants from southwest Florida. There have been a total of 27 students from Lee and Collier County schools who have applied to Yale for the class of 2009. Six applicants applied for early action which means that they must have their application filed by December 1, 2004. The applicant would know if they were admitted by December 15<sup>th</sup>. The ASC Newsletter from Yale reports that there were 3,931 early action applicants this year. This figure is down slightly from last year, and admission was offered to 704 students. The students came from 46 states and 48 foreign countries. Two of our candidates were admitted and have until April 1, 2005 to let Yale know their decision. I feel that both will matriculate this fall.

During December and January we were bombarded with interviews. The majority of the students were from Ft. Myers, but Naples schools did well, too. Mike Reilly from Ft. Myers did an outstanding job of interviewing these high school students. Rebecca Totaro also helped out. The students from Collier schools had to put up with me. As of this writing, it appears that the interviewing is coming to a close, and now we wait for the results.


